

## **ORDINANCE 2021.22**

### **AN ORDINANCE APPROVING THE CONSTRUCTION IMPROVEMENT PLAN SETS FOR STREET, STORM, STREET LIGHTING, WATER, AND SANITARY SEWER IMPROVEMENTS FOR ROLLING HILLS AND DECLARING AN EMERGENCY**

**WHEREAS**, the 2021 Construction Improvement Plan Sets for Street, Storm, Street Lighting, Water, and Sanitary Sewer for Rolling Hills have been completed and have been reviewed by the Sunbury Village Engineer; and

**WHEREAS**, the Sunbury Village Engineer recommends approval of said construction improvement plan sets for street, storm, street lighting, water, and sanitary sewer for Rolling Hills.

**NOW THEREFORE, BE IT ORDAINED** by the Council for the Village of Sunbury, County of Delaware, State of Ohio as follows:

**SECTION I:** That the following construction improvement plan sets for Rolling Hills are hereby approved:

1. Street, Storm Sewer, Street Lighting & Water Plan (2021)
2. Sanitary Sewer Improvement Plan (2021)

**SECTION II:** It is found and determined that all formal actions of this Council concerning and related to the adoption of this Ordinance were adopted in open meetings of this Council, and that all deliberations of this Council and of any of the committees that resulted in such formal action were meetings open to the public, and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

**SECTION III:** This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the citizens of the Village of Sunbury, Ohio, to allow construction of the public improvements for Rolling Hills to be commenced at the earliest possible date thus facilitating construction of homes for existing and future residents and to allow associated revenues committed to sanitary sewer infrastructure to begin collection at the earliest possible date.

**WHEREFORE**, this Ordinance shall take effect and be in force immediately from and after its passage.
