

RESOLUTION 2021.09

A RESOLUTION AUTHORIZING THE VILLAGE DIRECTOR OF FINANCE TO EXPEND FUNDS FROM POLICE IMPACT FEES TO PURCHASE PORTABLE RADIOS AND DECLARING AN EMERGENCY

WHEREAS, new development within the Village of Sunbury has contributed to and increased the need for additional communications equipment for Village law enforcement officers; and,

WHEREAS, pursuant to Sunbury Codified Ordinance 963.05 the Village Fiscal Officer has generated a written report setting forth the funds to be appropriated and expended from Police Department impact fees to address demands generated by the new development towards these policing needs and the benefits to new development; and

WHEREAS, Council wishes to accept the report of the Director of Finance and authorize the expenditure of police impact fee funds for additional communications equipment for use in the Village of Sunbury Police Department.

NOW THEREFORE, BE IT RESOLVED by the Council for the Village of Sunbury, Delaware County, State of Ohio, that:

SECTION I: The Village Director of Finance is hereby authorized to appropriate and expend the sum of twelve thousand eight hundred seventeen dollars and no cents (\$12, 817.00) from the Impact fees – Police Fund for one additional communications equipment.

SECTION II: The written report of the Director of Finance prepared pursuant to Sunbury Codified Ordinance 963.05 attached hereto as Exhibit “A” is hereby ratified and approved.

SECTION III: It is found and determined that all formal actions of this Council concerning and related to the adoption of this Resolution were adopted in open meetings of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public, and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION IV: This resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the citizens of the Village of Sunbury, Ohio to allow Police Department communications equipment needs to be met at the earliest possible date and thus providing maximum security and benefit to Village of Sunbury residents.

WHEREFORE, this Resolution shall be in effect immediately after its passage.
