

**RESOLUTION NO. 2021.11**

**A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Budget Commission of Delaware County, Ohio has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within the ten-mill tax limitation; and

**WHEREAS**, pursuant to ORC 5705.34, Council wishes to accept amounts and tax rates as determined and authorize the necessary tax levies and certify the same to the County Auditor.

**NOW, THEREFORE**, BE IT RESOLVED by the Council of the Village of Sunbury, Delaware County, Ohio, that:

**SECTION I:** The amounts and rates as determined by the Budget Commission in its certification be and the same are hereby accepted and approved.

**SECTION II:** That there be and is hereby levied on the tax duplicate of the Village of Sunbury, the rate of each tax necessary to be levied within and without the ten-mill limitation as provided in Schedule A hereby attached.

**SECTION III:** The Village Fiscal Officer is hereby directed to certify a copy of this Resolution to the Delaware County Auditor.

**SECTION IV:** This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and any of its committees and that all deliberations of this Council and of any of its committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

**WHEREFORE**, this Resolution shall take effect from and after the earliest time permitted by law.
