

## **ORDINANCE 2021.34**

### **AN ORDINANCE RATIFYING AND CONFIRMING EXPENDITURES MADE PURSUANT TO A TEMPORARY INCREASE IN THE NON-LEGISLATIVE PURCHASE ORDER AUTHORIZATION LIMITS TO TEN THOUSAND DOLLARS DURING THE PENDENCY OF THE STAY SAFE ORDER OR ANY SUBSEQUENT ORDERS OF THE OHIO DEPARTMENT OF HEALTH IN RESPONSE TO THE COVID-19 PANDEMIC AND DECLARING AN EMERGENCY**

**WHEREAS**, the Village of Sunbury previously approved Ordinance 2020-15 raising the limit on non-legislative purchase orders from \$4,000 to \$10,000 during the “stay at home” order issued by the Ohio Department of Health in response to the COVID-19 pandemic; and

**WHEREAS**, the “stay at home” order subsequently was revised to a “stay safe” order but the Village continued following various revised protocols including virtual meetings through June 2021 in response to the COVID-19 pandemic; and

**WHEREAS**, Council wishes to ratify and confirm all non-legislative purchase orders made in reliance on Ordinance 2020-15, from the date of its passage on April 8, 2020 through the date of this Ordinance, in response to the COVID-19 pandemic.

**NOW, THEREFORE, BE IT ORDAINED** by the Council for the Village of Sunbury, Ohio, Delaware County, State of Ohio as follows:

**SECTION I:** The authority to approve and execute non-legislative purchase orders pursuant to Sunbury Codified Ordinances 123.04 and 123.05 between \$4,000 to \$10,000 from the passage of Ordinance 2020-15 on April 8, 2020 through the date of this Ordinance is ratified and approved. A list of prior ratified and approved purchase orders is attached hereto as Exhibit “A”.

**SECTION III:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public, and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION IV:** This Ordinance is hereby declared to be an emergency measure to allow confirmation of said increased authority to be in effect and in force immediately to create certainty regarding prior purchase orders issued in response to the COVID-19 pandemic.

**WHEREFORE**, this Ordinance shall be in effect and in force immediately from and after its passage.
