

**ORDINANCE NO. 2023.01.1 First Amended**  
**AN ORDINANCE AMENDING THE 2023 ANNUAL APPROPRIATIONS**

**WHEREAS**, Council for the City of Sunbury has previously enacted an Ordinance setting annual appropriations for the year 2023; and

**WHEREAS**, Council now wishes to amend and increase the appropriation to the Planning & Zoning Pass Through Agency Fund – Contract Services line \$100,000.00 for various pass-through zoning expenses that are higher than originally anticipated; and

**WHEREAS**, Council now wishes to amend and increase the appropriation to the Cemetery Fund – Notes Payable line \$8,000.00 for principal and interest payable on current debt; and

**WHEREAS**, Council now wishes to amend and increase the appropriation to the General Fund – Police Capital \$20,000 for increased cost of new cruisers; and

**WHEREAS**, Council now wishes to amend and increase the appropriation to the General Fund – Admin Contractual Services \$220,000 for increased cost of legal and engineering fees related to various matters; and

**WHEREAS**, Council now wishes to amend and increase the appropriation to the General Fund – County Services \$7,500 for increased property tax payments, some of which have been refunded to the City and receipted as revenue in 2023; and

**WHEREAS**, Council now wishes to amend and increase the appropriation to the General Fund – Street Department Contractual Services \$105,000 for increased engineering costs related to various matters, and general maintenance/repairs of city-owned equipment; and

**WHEREAS**, Council now wishes to amend and increase the appropriation to the General Fund – Street Vehicle repairs \$15,000 for increased cost of vehicle repairs; and

**WHEREAS**, Council now wishes to amend and increase the appropriation to the Sewer Fund – Other Reimbursements by \$235,000 for repayment to a Developer for expenses previously incurred on behalf of the city to oversize a piece of sewer infrastructure; and

**WHEREAS**, all funds balances are sufficient to cover these appropriations.

**NOW, THEREFORE, BE IT ORDAINED** by the Council for the City of Sunbury, Delaware County, Ohio as follows:

**SECTION I. BE IT ORDAINED** by the Council of the City of Sunbury, State of Ohio, and hereby authorizes:

Increase P-Z Pass Thru Fund – Contract Services line item by One Hundred thousand dollars, (\$100,000.00).

Increase Cemetery Fund – Notes Payable line item by Eight thousand dollars, (\$8,000.00).

Increase General Fund – Police Capital line item by Twenty thousand dollars, (\$20,000.00).

Increase General Fund – Admin Contractual Services line item by Two hundred twenty thousand dollars, (\$220,000.00).

Increase General Fund – County Services line item by Seven thousand five hundred dollars, (\$7,500.00).

Increase General Fund – Street Contractual Services line item by One hundred five thousand dollars, (\$105,000.00).

Increase General Fund – Street Vehicle Repairs line item by Fifteen thousand dollars, (\$15,000.00).

Increase Sewer Fund – Other Reimbursements line item by Two hundred thirty-five thousand dollars, (\$235,000.00).

**SECTION II:** It is found and determined that all formal actions of this council concerning and related to the adoption of the Ordinance were adopted in open meetings of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public, and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

**SECTION III:** This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the citizens of the City of Sunbury, Ohio to allow the appropriation of said funds to be made without undue delay, thus allowing for the necessary expenditures at the earliest possible date.

This Ordinance shall take effect and be in force immediately after its passage.
