

**RESOLUTION NO. 2023.21**

**SUPPLEMENTAL RESOLUTION FOR SERVICES RELATED TO FIRE PROTECTION FOR PROPERTY KNOWN AS 78.017 ACRES OF LAND IN BERKSHIRE TOWNSHIP (2.002 ACRES) AND BERLIN TOWNSHIP (76.015 ACRES) DELAWARE COUNTY, OHIO**

**WHEREAS**, a Resolution for municipal services for 78.017 acres in Berkshire Township (2.002 acres) and Berlin Township (76.015 acres) upon annexation of said area to the City of Sunbury was passed November 18, 2020; and

**WHEREAS**, the Resolution for municipal services did not designate a service provider for fire protection services; and

**WHEREAS**, Council now wishes to designate BST&G Fire District as fire protection service provider for said 78.017 acres of land in Berkshire Township (2.002 acres) and Berlin Township (76.015 acres), Delaware County, Ohio.

**NOW, THEREFORE, BE IT RESOLVED** by the Council for the City of Sunbury, Delaware County, State of Ohio, that:

**SECTION I:** BST&G Fire District is hereby designated as fire protections service provider for said 78.017 acres of land in Berkshire Township (2.002 acres) and Berlin Township (76.015 acres), Delaware County, Ohio.

**SECTION II:** It is found and determined that all formal actions of this Council concerning and related to the adoption of this Resolution were adopted in open meetings of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public, and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

**WHEREFORE**, pursuant to Section 4.07 (A) of the Sunbury Charter this Resolution shall take effect and be in force immediately from and after its passage.
