**A RESOLUTION AUTHORIZING EXECUTION OF A GOVERNMENTAL
AGGREGATION SERVICES AGREEMENT FOR THE PROVISION OF
ELECTRICAL ENERGY FOR CITY OF SUNBURY PARTICIPATING
RESIDENTS AND BUSINESSES**

WHEREAS, Council has identified a continuing opportunity to secure competitive pricing of electric energy for the City of Sunbury participating residents and businesses pursuant to its electric aggregation program; and

WHEREAS, Council has been briefed on the current electrical energy market and wishes to authorize its energy consultant, Scioto Energy, to secure final pricing for a government aggregation services agreement; and

WHEREAS, Council wishes to authorize the City Manager to execute a Governmental Aggregation Services Agreement with the energy services supplier offering the best pricing for a term of twenty four months and at a rate not exceeding 10.65¢/kWh;

NOW, THEREFORE, BE IT RESOLVED by the Council for the City of Sunbury, Ohio, Delaware County, State of Ohio as follows:

SECTION I: Council hereby approves a governmental aggregation services agreement for the provision of electric energy to the City of Sunbury participating residents and business from the energy services supplier offering the best final pricing to Scioto Energy on behalf of the City of Sunbury for a term of twenty-four months beginning with the May 2026 meter reads at a rate not exceeding 10.65¢/kWh. This approval is conditional upon final legal review of the services agreement and other necessary documents.

SECTION II: The City Manager is hereby authorized to execute the agreement as required and any other related or necessary documents consistent with this legislation.

SECTION III: Council specifically determines this proposal and all related procedures to be in compliance with Article IX paragraph 9.02 (F) of the Charter of the Sunbury.

SECTION IV: It is found and determined that all formal actions of this Council concerning and related to the adoption of this Resolution were adopted in open meetings of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public, and in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION V: Pursuant to Section 4.07 of the Charter of the City of Sunbury, this Resolution shall be in effect immediately after its passage.
